Madame Chair and Members of the Committee:

Your Subcommittee has reviewed the Governor's introduced budget for public education.

The introduced budget reflected many of our priorities in public education and the Subcommittee maintains in our recommendations: a five percent salary increase each year for teachers and staff; \$500.0 million in one-time cash for school construction; funds to hold divisions harmless for rebenchmarking data affected by COVID-19 school closures; funding to support learning for students at-risk of falling behind; investments in our early childhood programs; infusions and sustained contributions into the teacher retirement plan; and ensuring Literary Funds are available to support school construction loans and subsidies.

As the Subcommittee developed our recommendations, we focused our efforts on ways to acknowledge our educators and school staff for their commitment to our children, address unfinished learning among our students, and assist in the preparation of the educator pipeline.

Overall, our recommendations provide an additional \$115.0 million in FY 2023 and \$159.0 million in FY 2024 above the introduced budget. This increases Direct Aid spending by \$1.5 billion in FY 2023 and \$1.2 billion in FY 2024 for a total increase of \$2.7 billion over the biennium.

We propose almost \$272.0 million over the biennium to provide more state funding for the support positions already employed by divisions. This

is a step towards eliminating the funding cap placed on support positions that was implemented nearly a decade ago. This ensures that the Commonwealth is recognizing more of the actual costs to provide students and instructors with the necessary supports, so students can be prepared to engage in learning.

We also recommend \$137.0 million from ARPA to provide our funded teachers and support staff with a bonus, of approximately \$1,000 per position, in June. The Subcommittee understands the burden already placed on divisions to match the five percent salary increases in the next biennium. Therefore, the funds provided are sufficient to fund the entire cost of the bonuses for the SOQ funded instructional and support positions and require no local match.

The Subcommittee also recognizes how critical reading is for student success, especially among early learners. We recommend funding to provide a reading specialist for every 550 students in kindergarten through third grade with the flexibility to allow these specialists to work with students in fourth through sixth grade.

Other recommendations include: \$15.0 million from ARPA to provide \$5,000 recruitment incentives for teachers filling vacancies in hard-to-fill positions or hard-to-staff schools; \$4.0 million from ARPA to support existing before-school, after-school, or summer learning programs; \$1.5 million GF to support statewide efforts to increase our educator workforce; and, an additional \$500,000 GF to support teacher residency programs.

The Subcommittee continues with its commitment to support and respond to the challenges faced by our students and educators. I thank the Subcommittee members and I look forward to continuing our on-going work regarding the future of public education in the Commonwealth.

Local school divisions wishing to participate in this program shall report to the Department of Education the number of instructional position vacancies on August 15, 2022, no later than August 31, 2022. Based on this information, the Department shall communicate to each school division its available allocation from these funds, and school divisions shall communicate the availability of these funds in their recruitment. Such payments shall be based on \$2,500 per individual; however, for individuals hired in hard-to-fill positions or hard-to-staff schools, as defined by the Department of Education, the incentive payment shall be based on \$5,000 per individual. The Department of Education and the school divisions are authorized to prorate these amounts if the demand exceeds the initial allocation. Individuals employed by a local school division as of July 1, 2022, who transfer from a non-hard-to-staff school to a hard-to-staff school, as defined by the Department of Education, within the same division are eligible for the \$5,000 incentive payment. School divisions shall report to the Department of Education, in a format specified by the Department, all instructional hires in the 2022-2023 school year who qualify for this incentive payment, no later than November 30, 2022. No later than the first day of the 2023 General Assembly Session, the Department of Education shall report on the number of hires reported by each school division participating in this program and the anticipated amount of funding to be provided to each school division for payment to those individuals." Explanation:

(This amendment provides \$15.0 million NGF the first year from the federal State and Local Recovery Fund (SLRF) pursuant to the American Rescue Plan Act of 2021 to support teacher recruitment incentive payments to fill unfilled instructional positions in the 2022-2023 school year. Incentives payments will be based on \$2,500 per position, or \$5,000 per position for hard-to-schools and hard-to-staff positions.)
