

Virginia Health Benefit Exchange

- Established by the General Assembly as a division of the State Corporation Commission in 2020.
- Transitioned Virginia to a full state-based marketplace in November 2023.
- Operates Virginia's Insurance Marketplace, an online eligibility and enrollment portal for Qualified Health Plans and Qualified Dental Plans and Medicaid eligibility determinations.
- Works to reduce the number of uninsured individuals in Virginia and to support the continuity of coverage.
- Promotes a transparent and competitive marketplace; promotes consumer choice and education.
- Maintains a customer service center that provides year-round enrollment assistance.
- Supports a robust statewide assister network (navigators, agents, and assisters) that provides community-based outreach.


Funding

- Funded through non-general funds generated by carrier assessment fees.
 - FY25 appropriation is \$52 million
 - FY26 appropriation is \$54 million
- Funding supports Exchange operations, enrollment portal, customer service center, consumer outreach and education, marketing, and state-wide navigator programs.
- Drew down \$20 million of \$40 million working capital advance. Repayment will begin this fiscal year.

Virginia's Insurance Marketplace

- An online health and dental insurance marketplace where consumers can shop for and enroll in coverage.
- Connecting eligible Virginians to:
 - Qualified Health Plans and Qualified Dental Plans
 - Financial Assistance
 - Advance Premium Tax Credits
 - Cost-Sharing Reductions
 - Medicaid
- Supporting continuous coverage for those who are transitioning from other insurance options.

Update: Medicaid Unwinding Special Enrollment Period


Supporting Coverage Transitions

- Virginians who **lose** Medicaid coverage between March 31, 2023 and December 31, 2024 are eligible for a Special Enrollment Period to apply for Plan Year 2024 health coverage.
- After visiting Virginia's Insurance Marketplace and submitting an application, consumers will have 90 days to complete plan enrollment.

Update: Virginia's Easy Enrollment Program

A new pathway to access the Marketplace

- Enacted by the General Assembly in 2021.
- Beginning in 2025 for the 2024 tax year, Virginia consumers can request information about enrollment on their state income tax form.
- Outreach will be provided to consumers requesting information.
- Consumers will be given a Special Enrollment Period.
