FY24 Budget Overview

General Assembly Actions

- 2023 Special Session I reduced FY24 Budget from \$11.2 million to \$5.3 million
- \$2.5 million available for one-time seed-to-sale tracking system

- Funding for hemp advertising enforcement

Medical Cannabis Program

October 2022: Transition meetings begin with Board of Pharmacy

Summer 2023: CCA begins hiring medical cannabis program staff, launches technology development, and starts developing regulations.

October 2023: CCA Board of Directors approves regulations for oversight of the medical cannabis program

December 2023: Licensing and patient portals go live -- all data are transferred from Board of Pharmacy into CCA systems

January 2024: CCA begins oversight of the medical cannabis program.

February 2024: CCA starts process to select a pharmaceutical processor to operate in Health Service Area 1; conditional approval granted to selected applicant by end of June 2024.

CCA Safe Driving Survey Results

30% of Virginians think marijuana makes them a safer driver.

47% of marijuana users don't always have a plan for a sober ride.

14% of Virginians have driven high a few times a year or more.

24% of Virginians have ridden as a passenger in a car with a high driver more than one time over the past year.


