SB625	Deeds	Medical Education Loan-for-Service Fund and Program established, report.
SB759	Ebbin	Unemployment benefits; increase weekly benefit amount; emergency.

<u>SB98</u>	Stanley	Virginia Emergency Management Preparedness & Capabilities Grant Program & Fund; established, report.
<u>SB99</u>	Stanley	Medical malpractice; limitations on recovery, certain actions.
<u>SB378</u>	Surovell	Public employees; repeals existing prohibition on collective bargaining, etc.
<u>SB644</u>	Surovell	Minimum wage and overtime wages; payment, misclassification of workers, civil actions.
<u>SB128</u>	VanValkenburg	Covenants not to compete; includes health care professionals, civil penalty.
