Overview of Program Prior to July 1^{st}

Program benefit:

- Tuition and fee waivers at public institutions in Virginia for up to four years/eight semesters. Waiver is applicable to any degree program.
- An additional stipend of up to \$2,200 to support other education expenses for <u>certain beneficiaries</u>.

Eligibility: Spouse or a child* between the ages of 16-29 of a veteran who served in the Armed Forces, Reserves, or National Guard who:

- While serving in active duty during military operations, on a peacekeeping mission, or in an armed conflict was killed or became a prisoner of war; or
- Is at least 90 percent disabled due to such service and has been discharged or released under conditions other than dishonorable.

Note: *Stepchildren are eligible if the veteran is deceased due to military operations and the child was claimed on their tax return or the Defense Enrollment Eligibility Reporting System while serving on active duty.

Overview of Program Prior to July 1st (continued)

Residency/domicile: Required to have domicile:

- At the time of entering active service or called to duty; or
- At least five years immediately prior to, or had a physical presence at least five years immediately prior to, the date on which the admission application was submitted.
- Additional domicile/residency is provided for survivors and dependents of a veteran who is deceased.

Beneficiaries of stipend program: Eligible spouses and children of a veteran who was killed or prisoner of war or who is at least 90 percent disabled as a direct result of military service operations.

Who Administers the Program?

Department of Veterans Services (DVS):

- Markets the program to eligible individuals;
- Certifies initial eligibility through an application process; and
- Monitors ongoing eligibility and use of benefits, including four-year limitation (eight semesters).

State Council of Higher Education for Virginia (SCHEV):

- Reimburses institutions for stipends;
- Collects and reports data from institutions; and
- Issues guidance related to state financial assistance programs and domicile/residency to institutions.

How is the Program Supported?

- Tuition and fee waivers:
 - Provided by the institutions (foregone revenue).
- Stipends:
 - \$9.7 million GF in FY 2025 and FY 2026.
 - Allocated to SCHEV to reimburse institutions.



SCHEV reports that these students were captured as out-of-state in fall and were later changed to in-state in the summer semester. While this creates a duplicate count, the total waiver amount is the same. The public 4-year category includes Eastern Virginia Medical School, as it is in the process of merging with Old Dominion University.

Summary of Waiver Concerns Raised by Institutions and SCHEV

- Institutional concerns in six-year plans. Growth in VMSDEP tuition and fee waivers was a consistent theme in institution six-year plans. These plans were reviewed by the Secretary of Education, Secretary of Finance, Department of Planning and Budget, SCHEV, and staff directors of HAC and SFAC and reported to the Governor and General Assembly.
- SCHEV included options to change the program in its annual budget recommendations to the Governor and General Assembly in January 2024. SCHEV estimated waiver amounts could increase to \$180.0 \$190.0 million annually by FY 2026 based on recent annual percentage growth. Recommendations included options to provide support to institutions and manage the growth in waivers, including:
 - Funding half of the marginal increase of total tuition and fee waiver amounts (estimated at \$33.3 million in FY 2025 and \$60.5 million in FY 2026).
 - Policy modifications that could include one or more of the following: prioritizing undergraduate students, in-state students, requiring FAFSA, and applying other forms of aid first.

VMSDEP – Summary of 2024 Session & Special Session Proposals

- <u>SB 347 (Reeves), 2024 Session</u>: As introduced, proposed changes to the Program, including: limiting use to undergraduate programs; requiring in-state residency and completion of a FAFSA; and leveraging other sources of federal and state aid to apply to the waiver. It also proposed expanding the program from stepchildren of deceased military survivors to include stepchildren of veterans who are at least 90 percent disabled.
 - A substitute was passed in the Senate Education and Health Committee to change the bill to a study, and the Senate Finance and Appropriations Committee adjusted the study language, primarily to require that the Secretary of Finance lead the study.
 - The bill passed the Senate (40-Y; 0-N) and the House Appropriations Committee continued the bill to 2025 by a voice vote.
- <u>The Senate budget</u> proposed a policy approach consistent with SCHEV recommendations and similar to SB 347, as introduced (excluding the expansion to include stepchildren). The Senate excluded students eligible as of 2023-2024 who maintain enrollment (with exceptions) from proposed changes.
- <u>The House budget</u> proposed \$20.0 million GF annually to SCHEV to reimburse institutions for waivers and included similar changes to eligibility requirements consistent with SCHEV recommendations. It differed by applying changes to all tuition waiver programs and included a financial need component. Changes applied to current waivers and all future waivers.
- <u>Chapter 2, 2024 Special Session I budget</u> language and funding was based primarily on the language included in the House budget with the addition of a hold harmless, described on the next slide.

SB 6009, 2024 Special Session I

- Provides an additional \$45.0 million from the anticipated FY 2024 surplus to support tuition and fee waivers. With the amounts included in Chapter 2, 2024 Special Session I, this provides a total of \$65.0 million in FY 2025.
- Proposes a delayed effective date of July 1, 2025.
- Requires a JLARC study (completed by September 1, 2024) to review the long-term sustainability of the Program, including:
 - analysis of participant data;
 - assessment of waiver costs reported by institutions;
 - identification of practices to support education and other benefits for veterans and their families compared to other states; and
 - methods to estimate enrollment and costs.
