| <a href="#"><u>SB1110</u></a> | Williams Graves | Weapons; possession prohibited in a hospital that provides mental health or developmental services.                         |
| <a href="#"><u>SB1134</u></a> | Boysko          | Storage of firearms in a residence where a minor or person prohibited from possessing a firearm is present; penalty.        |
| <a href="#"><u>SB1181</u></a> | Deeds           | Purchase, possession, sale, transfer, etc., of assault firearms and certain ammunition feeding devices prohibited; penalty. |
| <a href="#"><u>SB1182</u></a> | Deeds           | Capitol Sq. or building owned/leased by the Commonwealth, carrying firearm/explosive material, etc.                         |
