Overview/Resources

SFAC Budget Priorities

- Continuing to invest in the people through better resourced schools, safer communities, enhanced workforce development opportunities, and health and housing resources.
- Increases reserve balances by more than \$904.6 million. Combined reserve balances will be nearly \$4.2 billion by the end of the next biennium.
- Large investments in the public workforce:
 - Proposes to increase pay by seven percent in FY 2024 for all state and state-supported local employees, including teachers; and a
 - One-time \$1,000 bonus for state employees and for SOQ funded teacher and support positions.
- Maintains liquidity and structural balance (includes cash for capital, one-time spending, voluntary VRS deposit/rates, contingent one-time items, etc.).

Tax Policy Language

- Local Option 1% Sales Tax for School Construction (Part 4): Allows any city or county (currently certain localities have this option) to impose an additional local sales tax of up to 1.0 percent for construction or renovation of schools. Current law, requires a local referendum and the tax expires when bonds or loans are repaid or no more than 20 years after the resolution if not financed by bonds or loans.
- **Sports Betting Deduction Bonuses and Promotions (Lottery)**: Maintains current language allowing full deductibility of the value of bonuses for the first 12 months an operator offers wagering. After 12 months of offering wagering, limits the deduction to the value of 1.75 percent of a permit's monthly wagering activity.
- **Historic Rehabilitation Tax Credit (Part 3)**: Increases the per taxpayer credit cap from \$5.0 to \$10.0 million and caps the aggregate credits claimed at \$120.0 million.
- Rolling Conformity Taxpayer Relief Fund (Part 3): Deposits \$75.0 million into the Rolling Conformity Taxpayer Relief Fund to offset the impact from conforming to federal tax provisions that increase or decrease general fund revenue by \$25.0 million or less on a rolling basis rather than a fixed-date basis. SB 1405 establishes a cumulative cap on all amendments to be adopted on a rolling basis at \$75.0 million, and this Fund provides an offset for any revenue reduction.
- Education Improvement Scholarship Tax Credit (Part 4): Extends a sunsetting definition of an eligible student with a disability to receive an Education Improvement Scholarship from January 1, 2024 to January 1, 2028.



SB 800 + SFAC Amendments – Contingent Policies


- Includes \$995.2 million for eight priority contingent allocations to be appropriated from FY 2023 year-end balances that are unobligated.
 - The allocations are to be obligated after any required deposit by the Constitution, the Code of Virginia, or by this Act and any amount needed to be reappropriated from unspent general fund appropriations but before the allocation of any remaining unobligated balance to the Commonwealth Transportation Trust Fund or for non-recurring capital expenditures.

- Providing the net remaining ٠ mandatory deposit of \$406.0 million to the Revenue Stabilization Fund.

Overview of Direct Aid

- **Introduced budget:** Proposed an additional \$441.9 million GF over the biennium.
- **SFAC amendments:** Provide an additional \$588.7 million GF resulting in an increase of \$1.0 billion over the biennium when added to the introduced budget.
 - Combined with increases in Chapter 2, 2022-24 Appropriation Act, this adds an additional \$3.9 billion in Direct Aid.

Higher Education

Overview of Higher Education

- SFAC amendments increase direct investments by \$263.1 million GF for the biennium to support access, affordability, completion, and workforce initiatives. Additional funds included in central appropriations.
- Increases overall investment in higher education by \$1.1 billion when accounting for the increases provided in Chapter 2, 2022-24 Appropriation Act and the introduced budget.

Higher Education: Language Changes

- SCHEV Tuition Assistance Grant: Maintain online rate at \$2,500.
- SCHEV Mental Health Services: Adjust language to remove secondary and elementary schools.
- VCU Health System: Remove introduced language regarding governance.
- Joint Subcommittee on Funding Policies and Enrollment Management: Adjust previous language and reconvene subcommittee.

Health and Human Resources

Overview of Health and Human Resources

- SFAC amendments include \$264.4 million GF in net spending over the introduced budget. Over Chapter 2 (2022 Special Session I), the total is a **net increase** of \$150.9 million GF over the biennium. Major spending amendments include:
 - \$379.1 million in behavioral health funding (\$54.0 million NGF);
 - \$196.0 million GF for Medicaid provider rate increases;
 - \$70.0 million GF to fund the Medicaid Forecast and offset lower Health Care Fund revenue;
 - \$38.7 million GF for healthcare workforce programs;
 - \$29.0 million GF to increase the Auxiliary Grant rate;
 - \$15.7 million GF for caseload growth in the TANF Unemployed Parent Program; and
 - \$15.1 million GF to add 500 developmental disability waiver slots.
- Major GF savings amendments total \$645.9 million and largely reflect federal match rate savings from extensions of the public health emergency.

- \$450.0 million GF to supplement previously authorized capital project construction pools for inflation and cost overruns.
- \$78.5 million GF to support new construction or improvements for 19 stand-alone agency projects.
- \$43.3 million GF for a data facility at Jefferson Lab (contingent on a federal award).
- \$34.1 million GF for furnishings and equipment for capital projects nearing completion.
- \$20.3 million GF to support acquisition or planning for nine projects.
- \$20.0 million GF for the local stormwater projects.
- \$19.1 million GF for a capital pool of three projects.
- \$8.0 million GF in maintenance reserve for Norfolk State University.
- \$8.0 million GF in maintenance reserve for Virginia State University.
- \$8.0 million GF for deferred maintenance for George Mason University.
- \$6.9 million to supplement two existing projects.
- \$500,000 for pre-planning for the Renovation of Sitter and Barefoot Veterans Care Center (Richmond) and for replacement of Veterans Care Center (Roanoke).
