Madam Chair and Members of the Committee:

The Capital Outlay and Transportation Subcommittee reviewed the introduced budget as it relates to capital outlay and transportation.

As we worked towards amending the adopted budget, we maintained the sensible course of pay-as-you-go capital funding with significant one-time resources available. The General Assembly last year reserved \$400.0 million from the surplus to reduce tax-supported bond authorizations, which we endorse. With readily available one-time cash, our capital endorsements total \$1.3 billion in general fund cash with no additional tax-supported debt funding.

The priority of the Commonwealth should always be focused on maintaining our existing capital assets. The Subcommittee fully endorses the renovation of existing buildings, life safety projects, and deferred maintenance projects.

Our endorsements as compared to the adopted biennial budget include:

- Authorization for planning of a new state office building at the current Virginia Department of Transportation Annex site;
- \$40.0 million from the general fund to match local stormwater projects that reduce runoff pollution;
- \$77.3 million from the general fund across state agencies and higher education institutions for either life safety, building envelopes, or deferred maintenance projects; and
- \$504.9 million from the general fund for construction of higher education projects completing detailed planning.

In the area of Transportation, the Subcommittee continues the prudent fiscal practice of limiting general fund support or only providing general fund support when one-time funding is available. We endorse providing \$175.0 million for I-81 safety improvements from last year's surplus, as agreed upon in the 2024 session. We recommend an additional \$3.3 million from the general fund to support the actual operational needs of the Washington Metropolitan Transportation Authority to reflect the Commonwealth's share as we continue to explore opportunities for efficiencies with the Authority.

This completes the report of the Subcommittee on Capital Outlay and Transportation, and I would like to conclude by expressing my appreciation to the members of the Subcommittee for their diligent efforts in shaping these recommendations.

"A. From the appropriation and authorization provided in this Item, up to \$40,000,000 shall be provided to the Department of Environmental Quality for the Stormwater Local Assistance Fund, established in accordance with the provisions of Item 365 of this Act. In accordance with the purpose of the Fund set out in Item 365, the appropriation shall be used to provide grants solely for capital projects meeting all pre-requirements for implementation, including but not limited to: i) new stormwater best management practices; ii) stormwater best management practice retrofits; iii) stream restoration; iv) low impact development projects; v) buffer restoration; vi) pond retrofits; and vii) wetlands restoration. Such grants shall be in accordance with eligibility determinations made by the State Water Control Board under the authority of the Department of Environmental Quality.

B. The provisions of §§ 2-0 and 4-4.01 of this act and the provisions of § 2.2-1132, Code of Virginia, shall not apply to the projects supported by this Item."

(This amendment provides \$40.0 million GF the first year to the Stormwater Local Assistance Fund to provide matching grants to local governments for the planning, design, and implementation of stormwater best management practices.)
