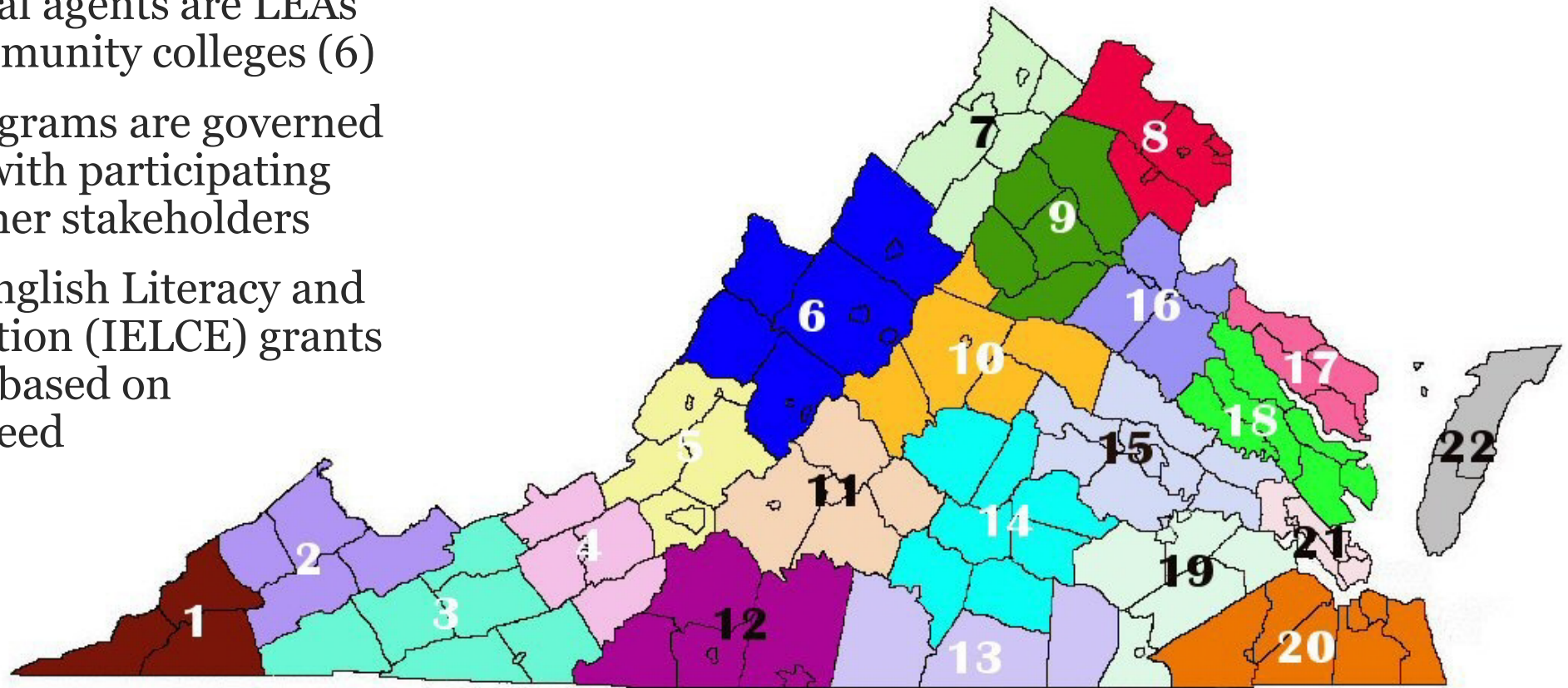

VIRGINIA DEPARTMENT OF EDUCATION

22 Regions, 16 IELCE grantees

- Regional fiscal agents are LEAs (15) and community colleges (6)
- Regional programs are governed by an MOU with participating LEAs and other stakeholders
- Integrated English Literacy and Civics Education (IELCE) grants are awarded based on population need

Eligible Providers

An organization that has demonstrated effectiveness in providing adult education and literacy activities:

- local education agency
- community-based literacy organization or faith-based organization
- volunteer literacy organization
- institution of higher education
- public or private nonprofit agency
- library
- public housing authority
- nonprofit institution that is not described previously and has the ability to provide literacy services to eligible individuals
- consortium or coalition of agencies, organizations, institutions, libraries, or authorities described previously
- partnership between an employer and an entity described above
- other

Eligible Individuals

An eligible individual for services funded through WIOA title II is one

(a) who has attained 16 years of age;

(b) is not enrolled or required to be enrolled in secondary school under state law [compulsory attendance age is 18 in Virginia]; and

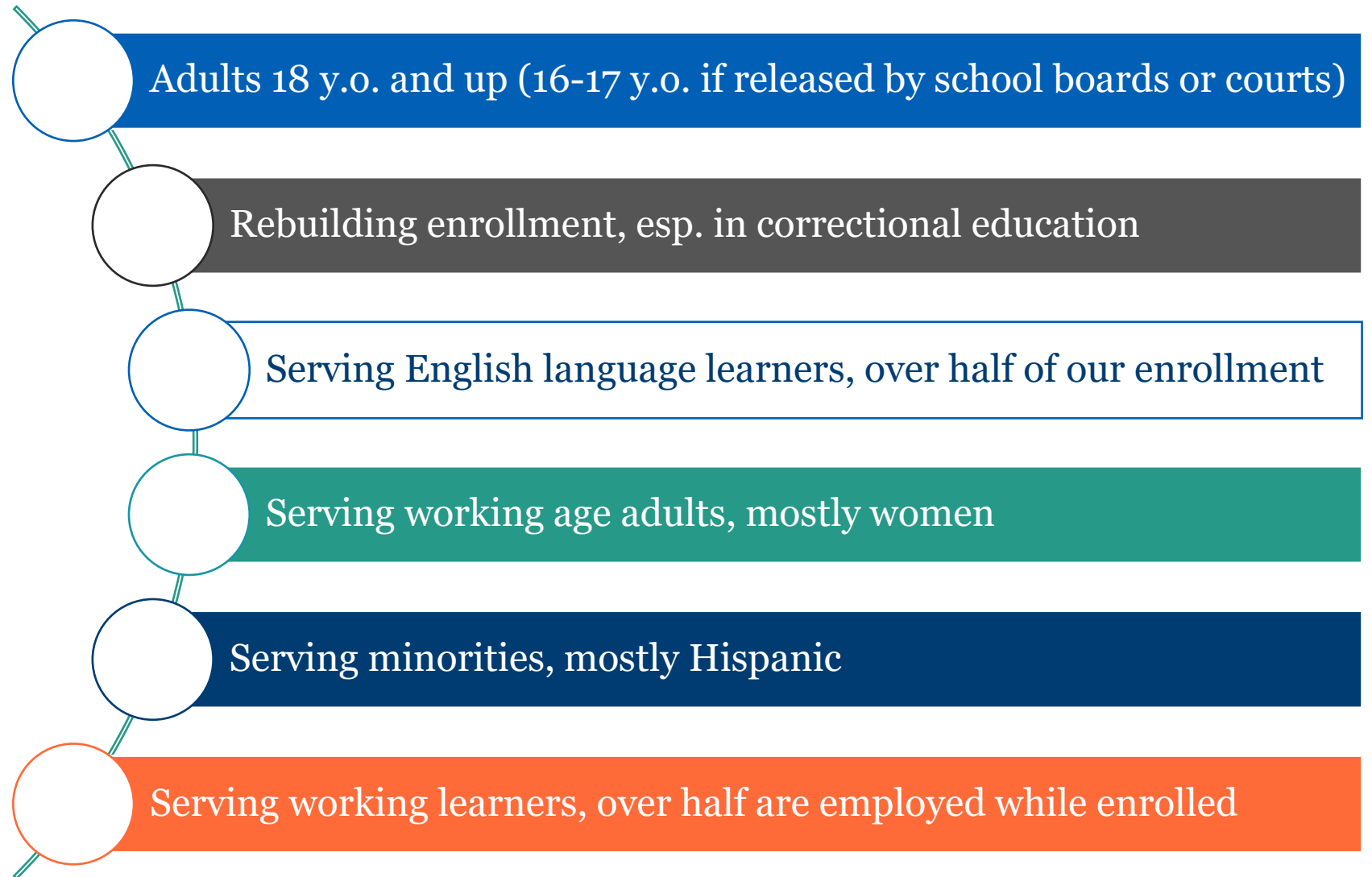
(c) who

i. is basic skills deficient;

ii. does not have a secondary school diploma or its recognized equivalent, and has not achieved an equivalent level of education; or

iii. is an English language learner.

Enrollment Trends

Rebuilding enrollment

- On trend with national declines and rebounds
- PY2021-22 enrollment 14,152
- PY2022-23 enrollment is on track to be higher

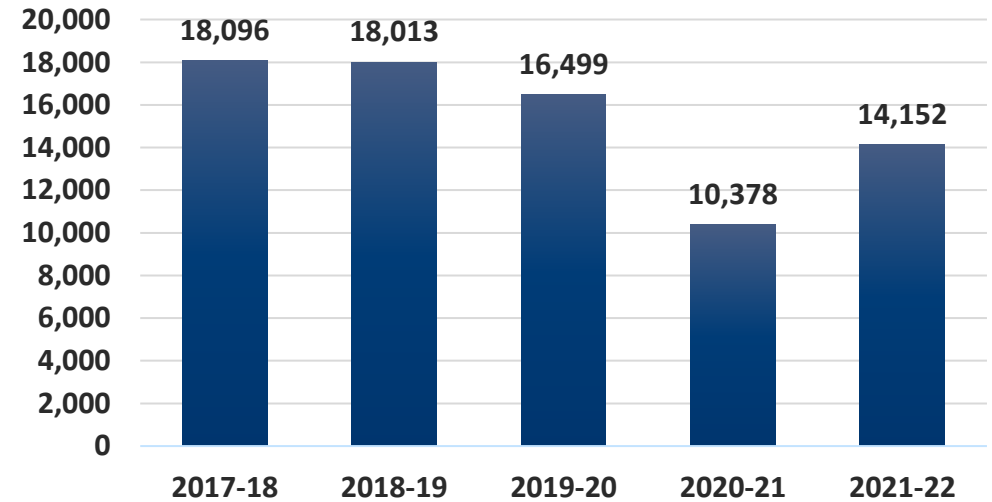
Retention rates have been high through the pandemic

- Provided tutoring and personal outreach

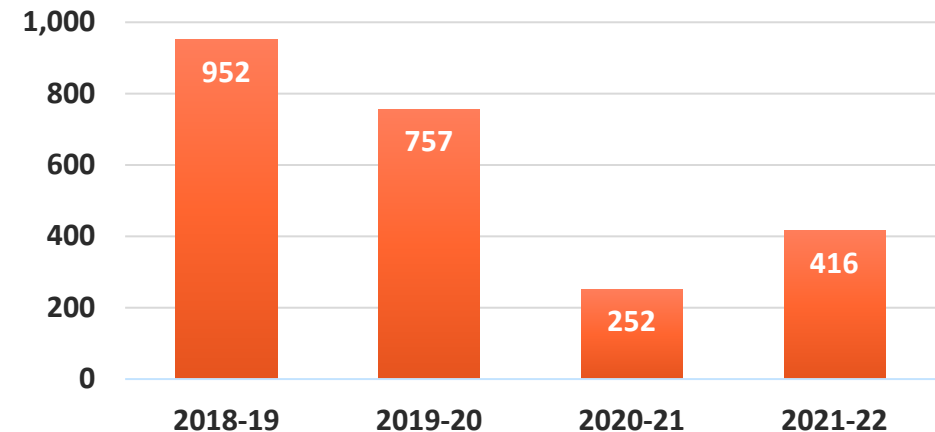
Correctional education enrollment dropped significantly

- PY2021-22 enrollment was not back to robust service, 424 participants

Enrollment



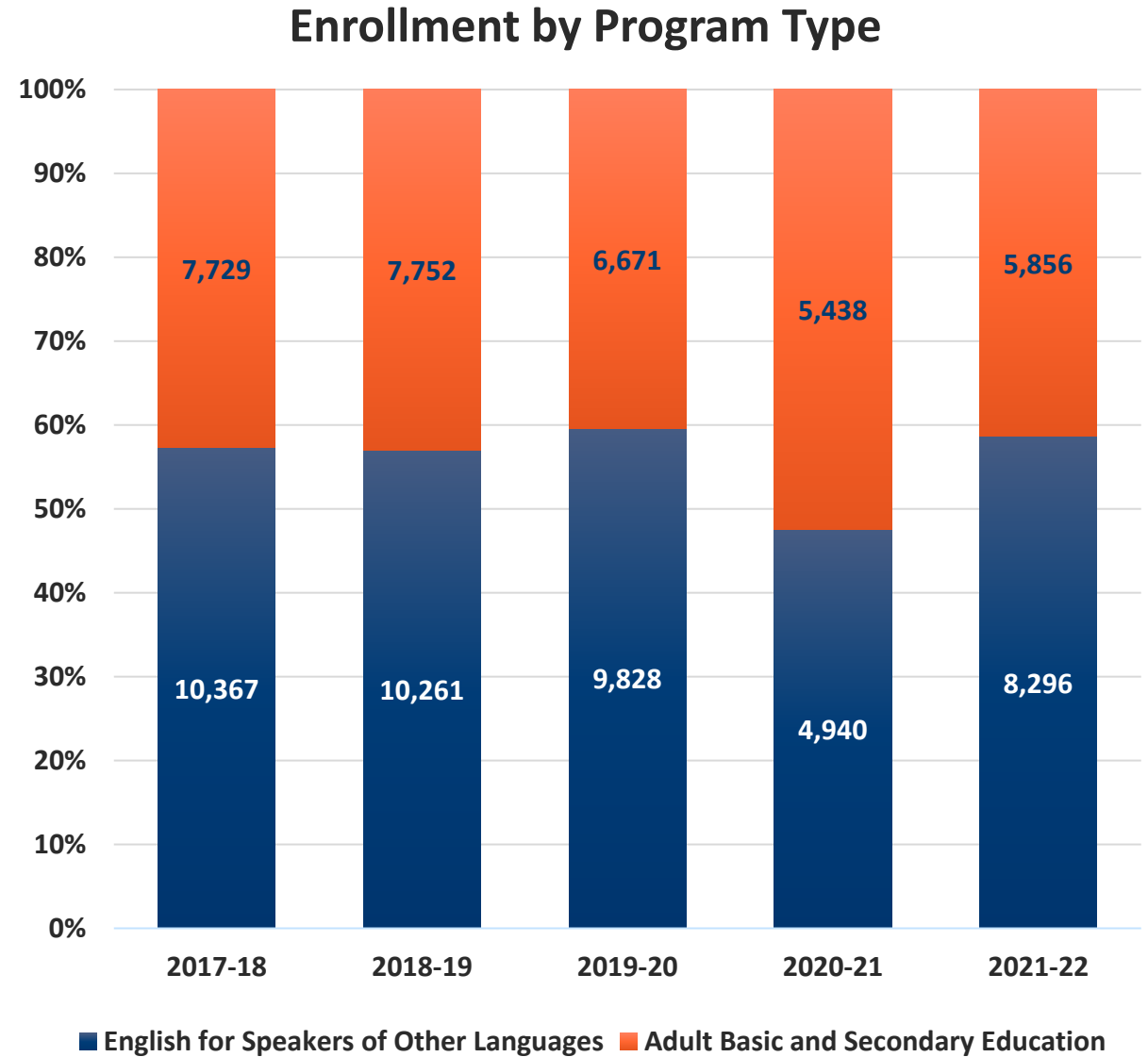
Enrollment in Correctional Education

- PY 2021-22 back on trend



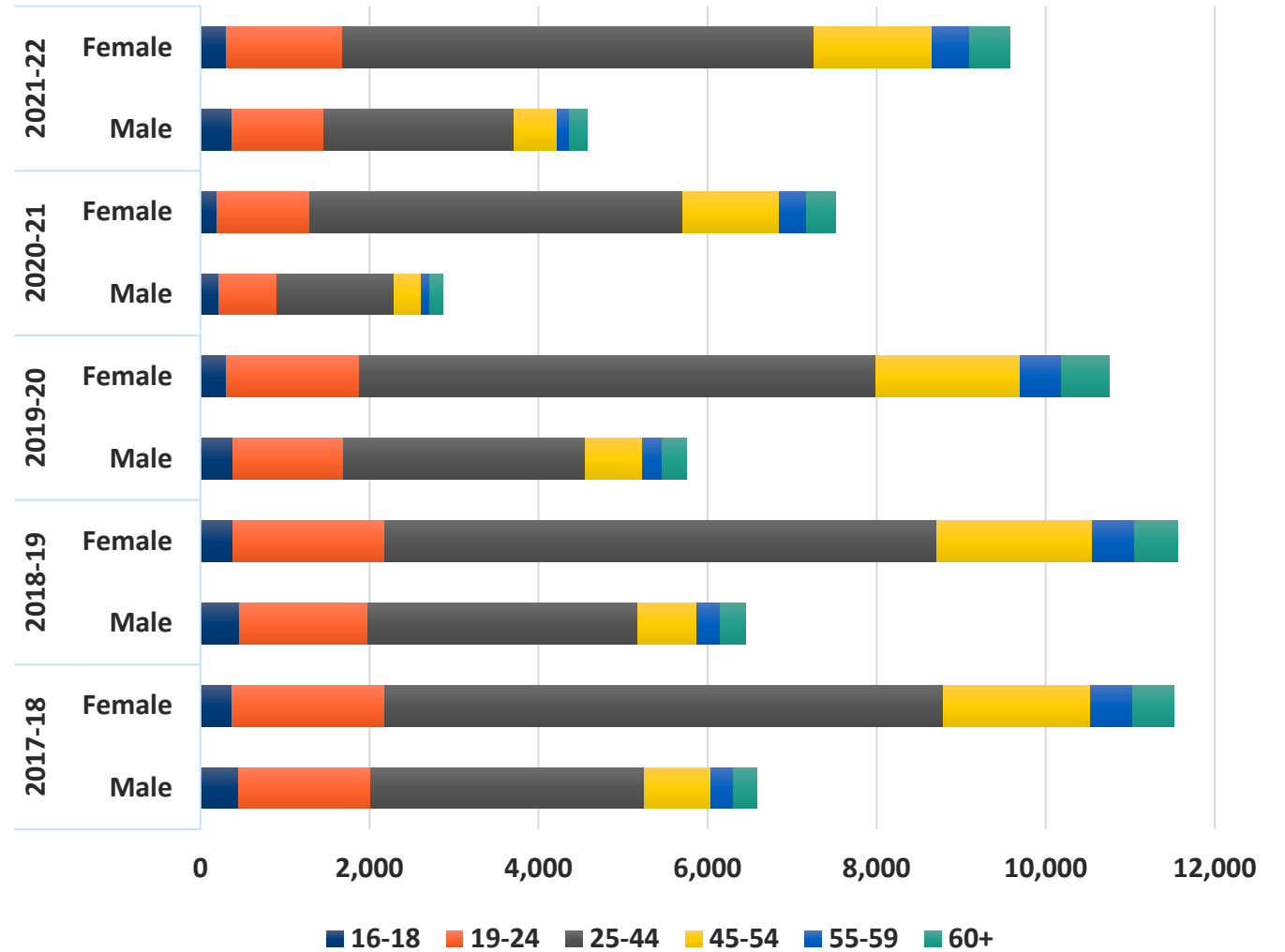
Serving Working Age Adults, Mostly Women

Largest age group: 25-44 y.o.

Over 65% of students are women

- PY2020-21, male enrollment declined the most
- PY2021-22 back on trend

Enrollment by Age and Gender

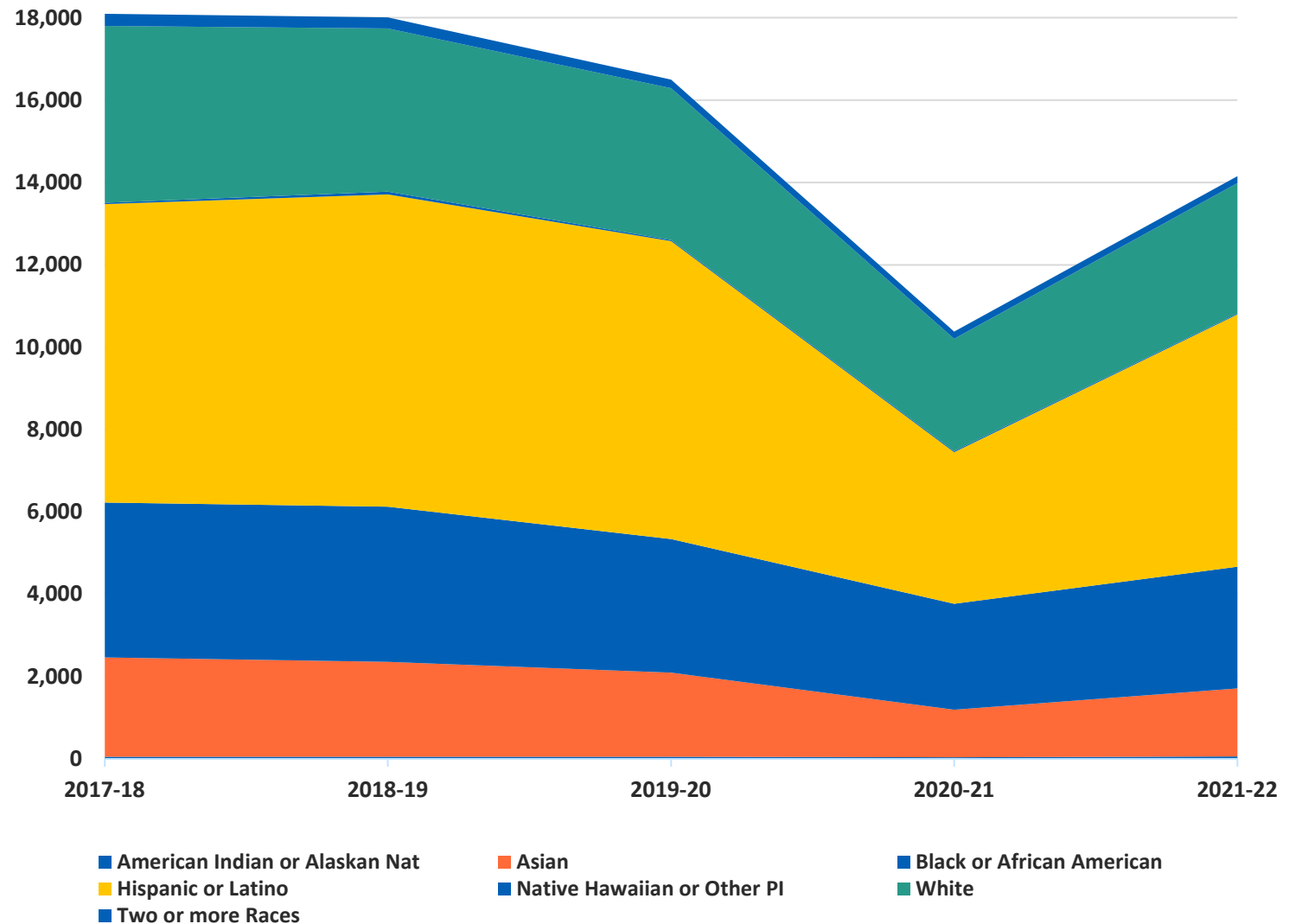


Serving Minorities, Mostly Hispanic

Single largest demographic group is Hispanic women

- 40% or more of the total enrollment is Hispanic women except for PY2020-21
- Hispanic enrollment dropped significantly during PY2020-21
- PY2021-22 back on trend

Enrollment by Race/Ethnicity

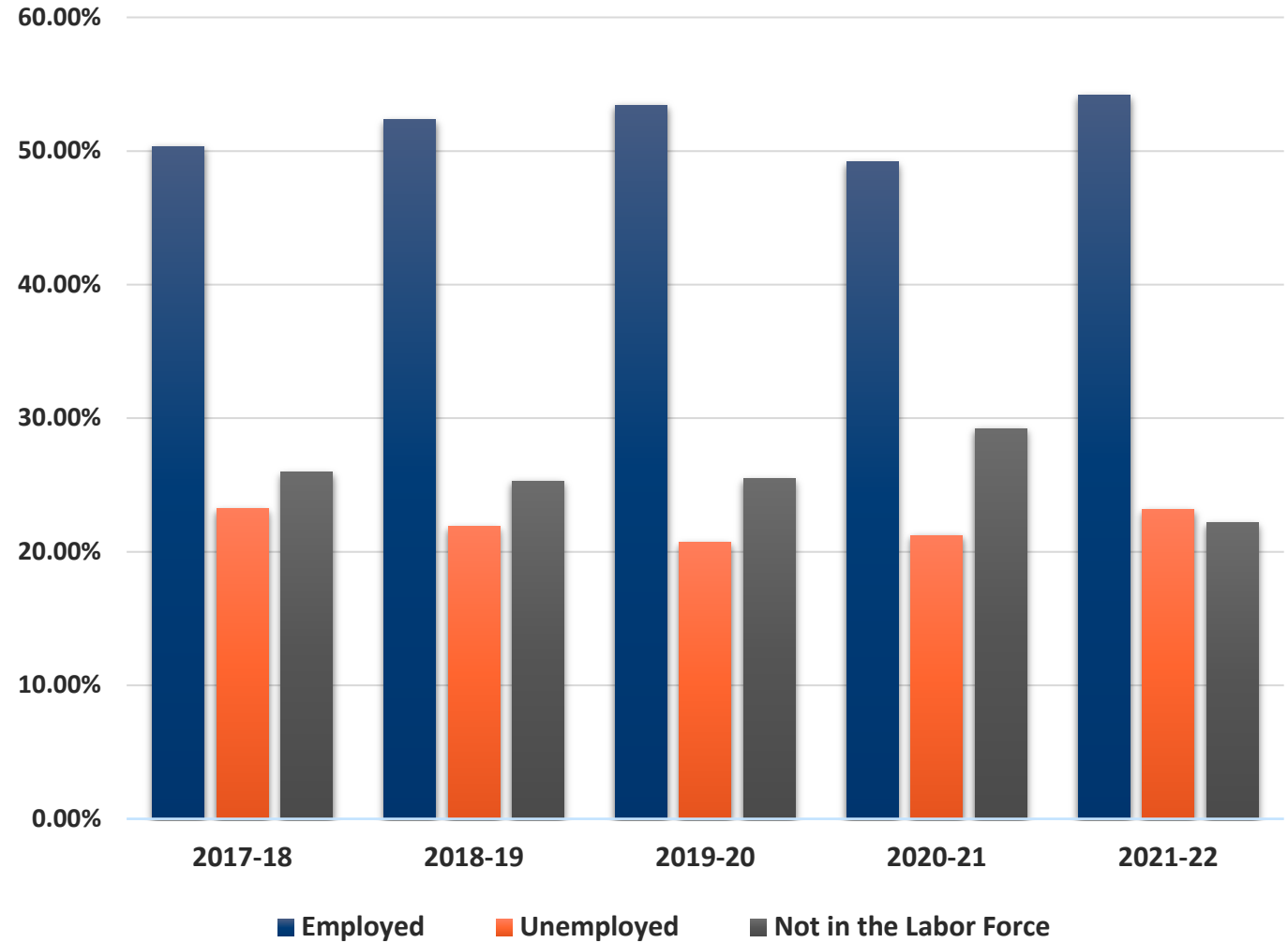


Serving Working Learners

Funding

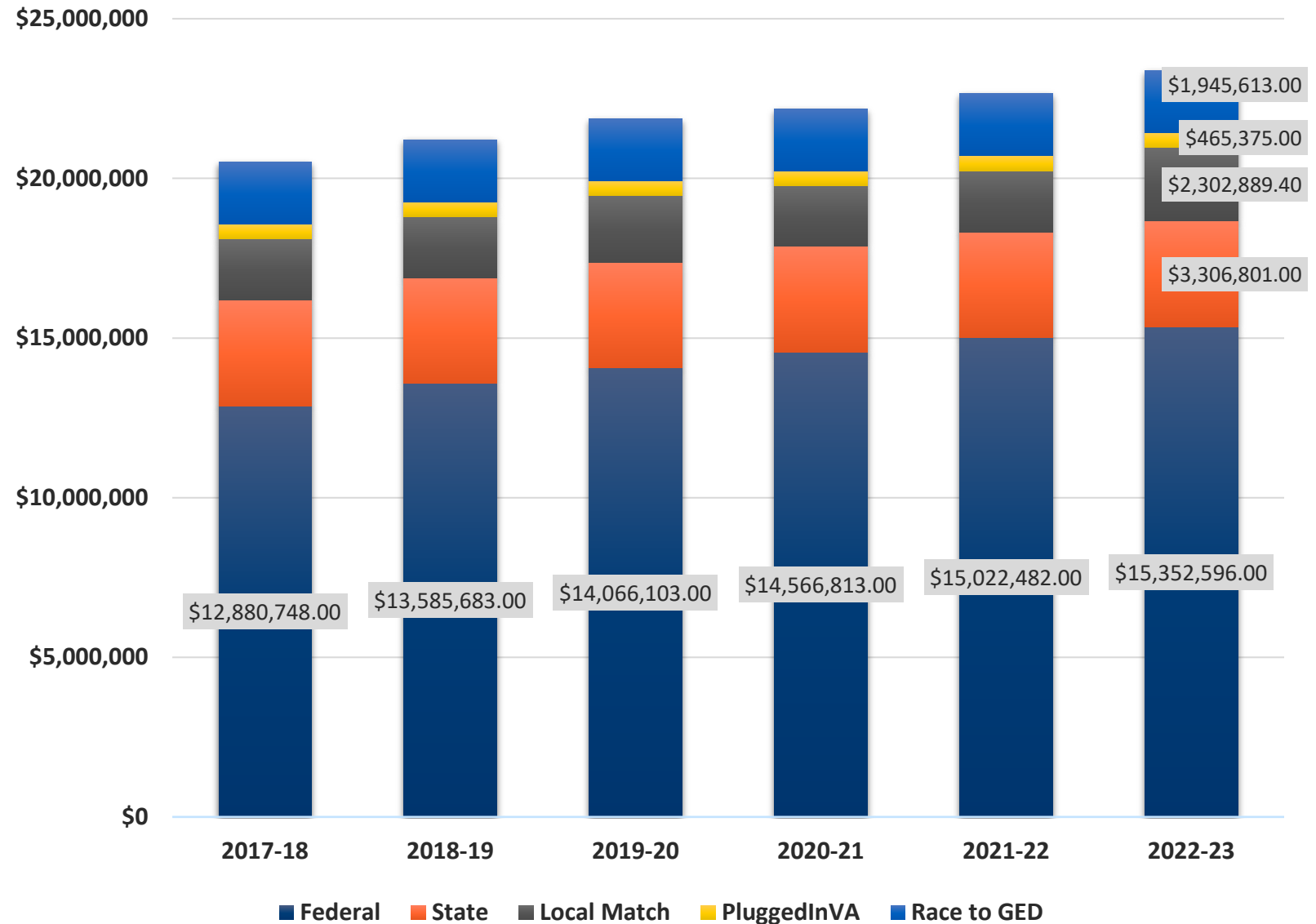
Federal awards have increased

State awards have remained stable

States are required to provide a 25% match

- State accounts for General Adult Education, Adult Literacy, and the PluggedIn Virginia funds are reported as match
- Localities are required by state requirement to provide a 15% match to the federal funds
- Race to GED funds testing sites, proctors, and test vouchers – it cannot be used as match

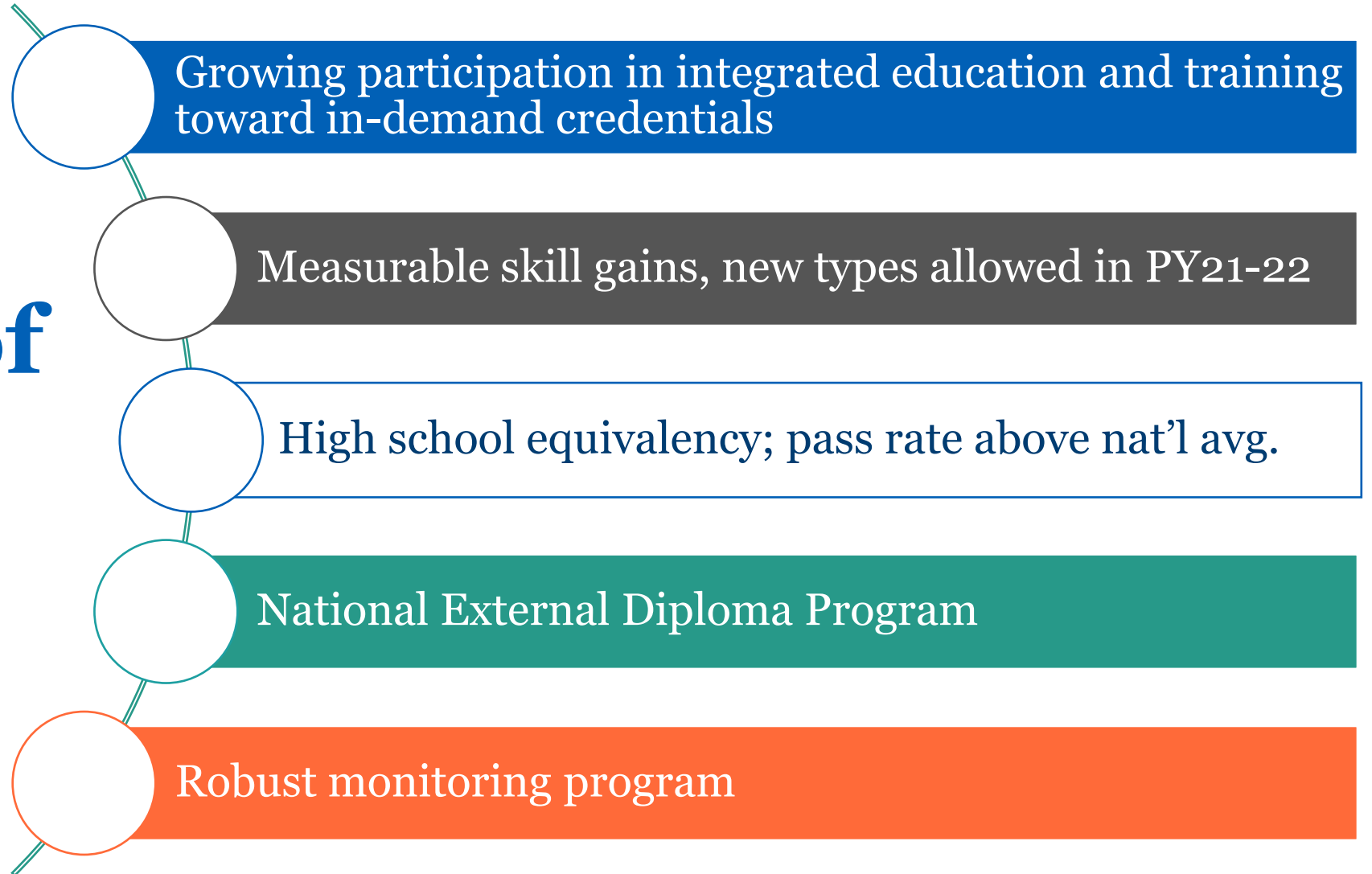
Awarded Funds and Match



Matching Funds

- Funds declared as state match must be expended according to the same regulations and allowances as the federal funds. Currently this applies to:
 - General Adult Education (GAE, \$1,051,800), supports instructional personnel and materials
 - Adult Literacy (State Lead Coordinating Agency, SLCA, \$2,255,000), supports the regional program manager and other coordinating staff for regional programs
 - PluggedIn Virginia (\$465,375 set-aside within the Race to GED line item), supports personnel and training costs for integrated education and training programming
 - Local match from school divisions and fiscal agents, can be cash or in-kind
 - Note: requiring a local match is a state, not federal, requirement
 - FYI: Virginia is one of the few states that require a local match and has a relatively low rate of state match at approximately \$8.00 per student (see Dec. 14, 2022 article at <https://www.propublica.org/article/literacy-adult-education-united-states>)
- Lottery funds (Race to GED®, PluggedIn Virginia) are only distributed to LEAs; community college fiscal agents work with one of their partnering LEAs to manage the reimbursement of these funds through the DOE.

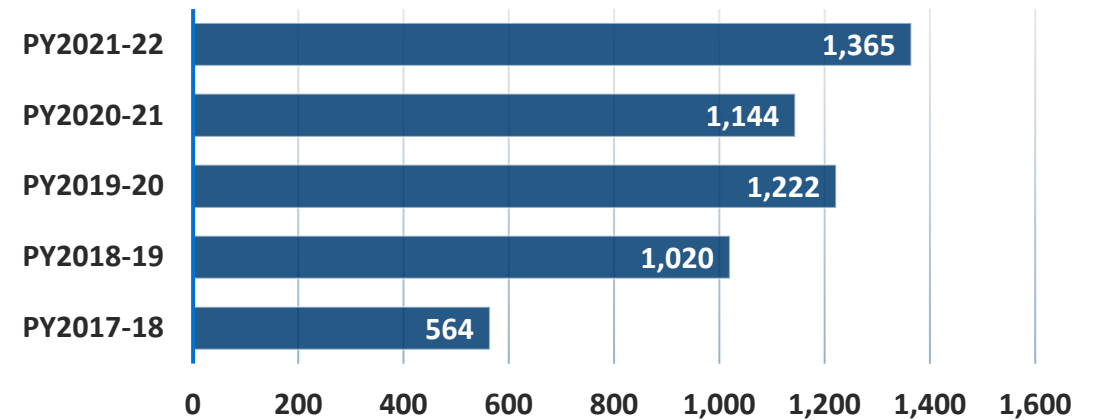


Growing Participation in Integrated Education and Training (IET)

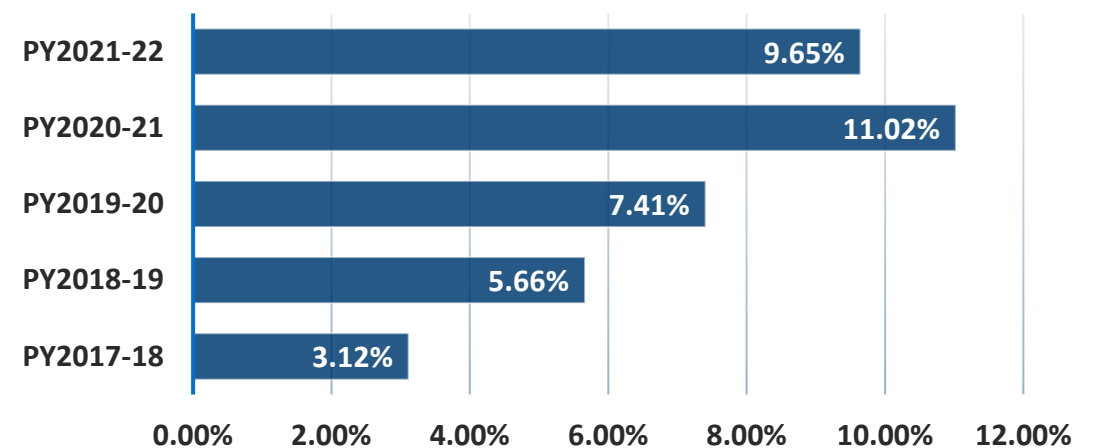

IET as a Percent of Total Enrollment

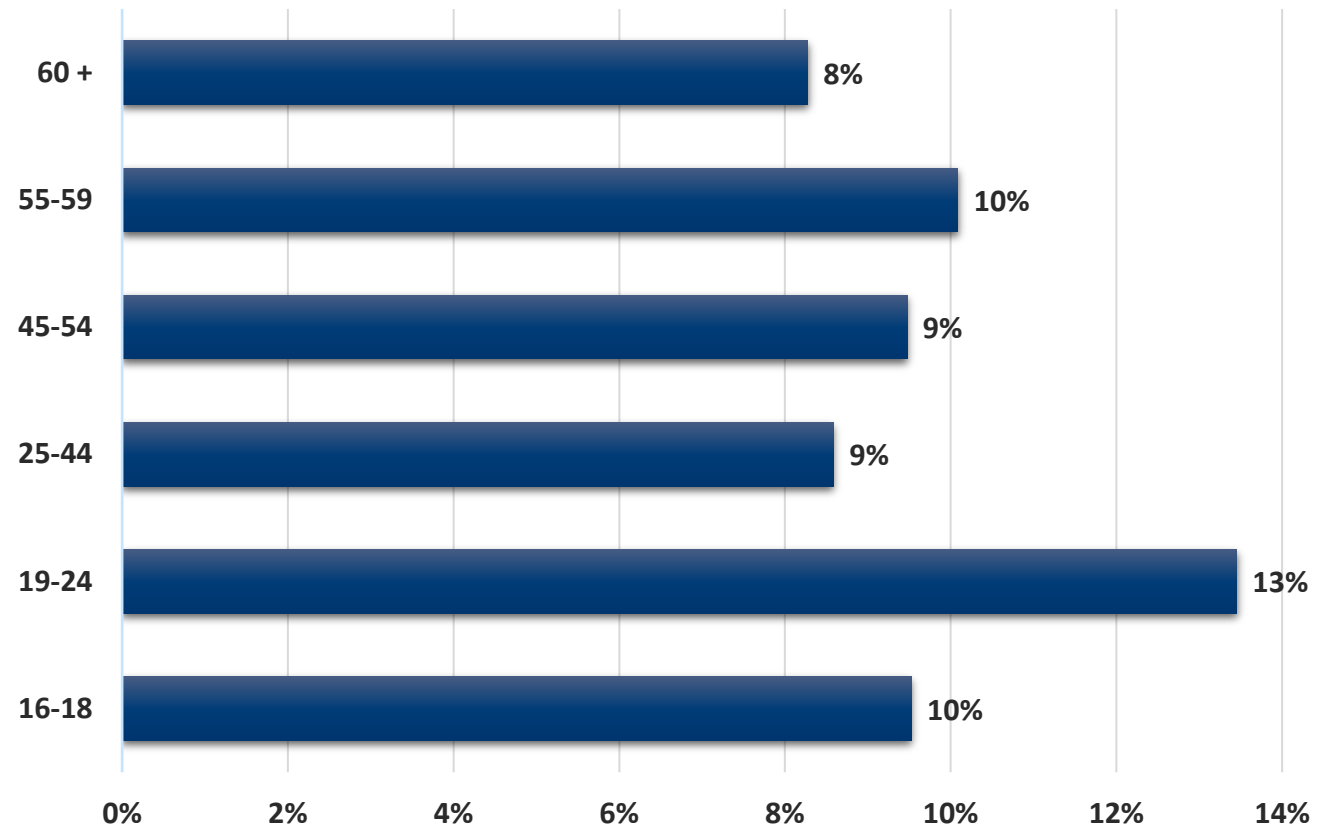


IET Participation by Age Group

(PY2021-22)



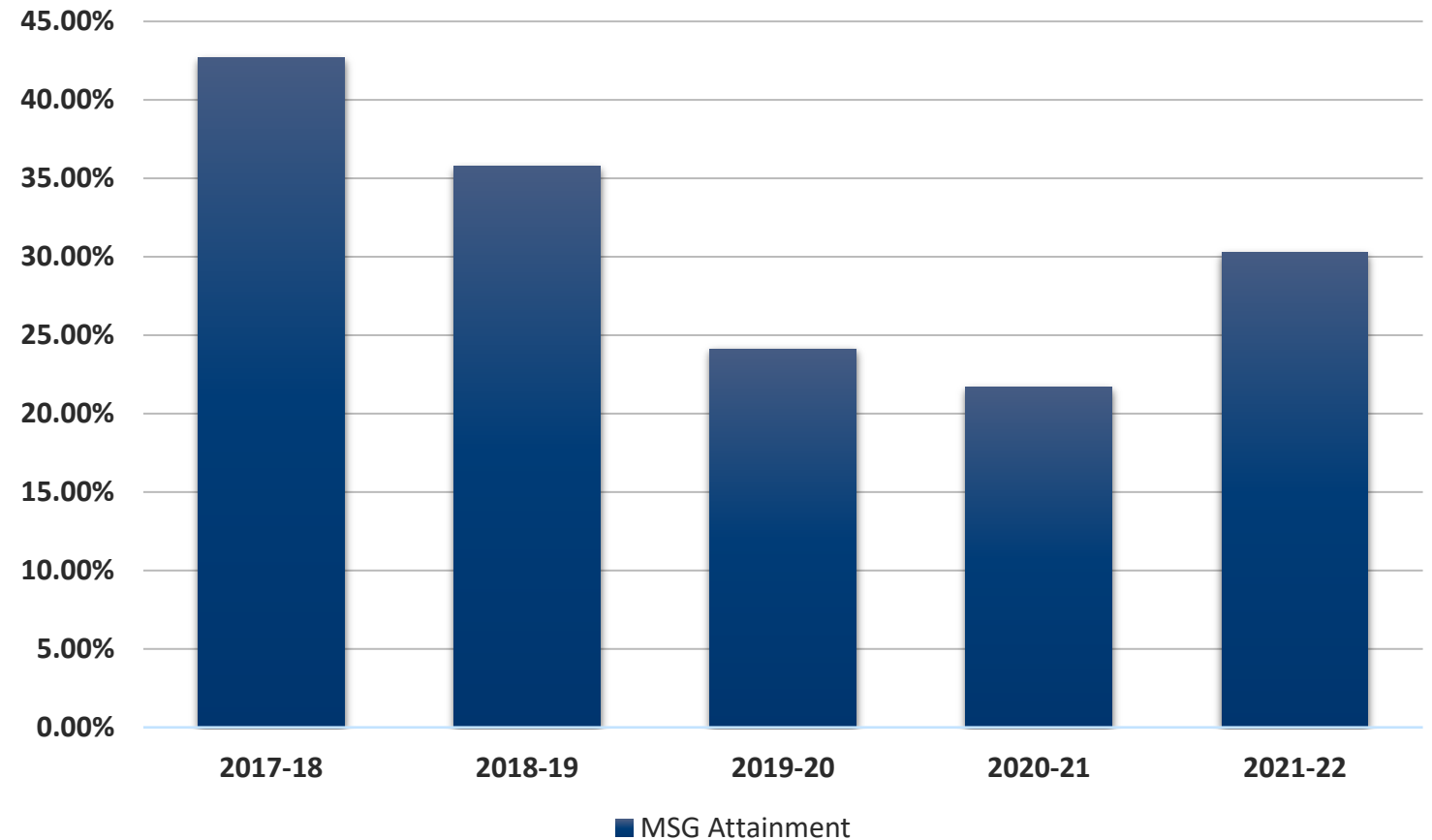
Measurable Skills Gain (MSG)

PY2021-22 added three types of MSGs for students in IET and workplace literacy



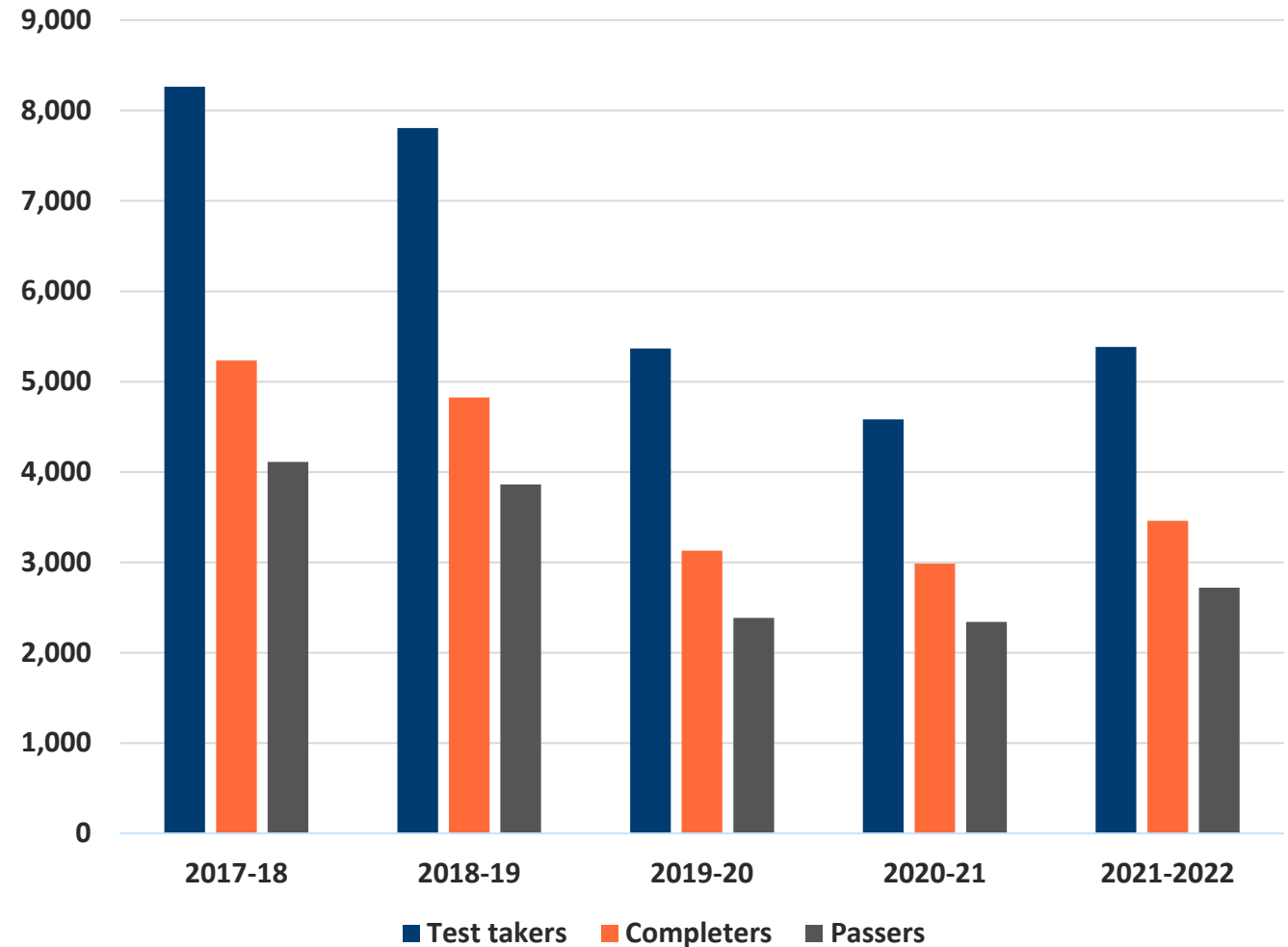
High School Equivalency Credential

Currently, the GED® is the only approved HSE test in Virginia

- There is an open application period every second year for the other vendor(s)

Virginia's pass rate, 79%, is above national average of 76%

GED® Testing Statistics



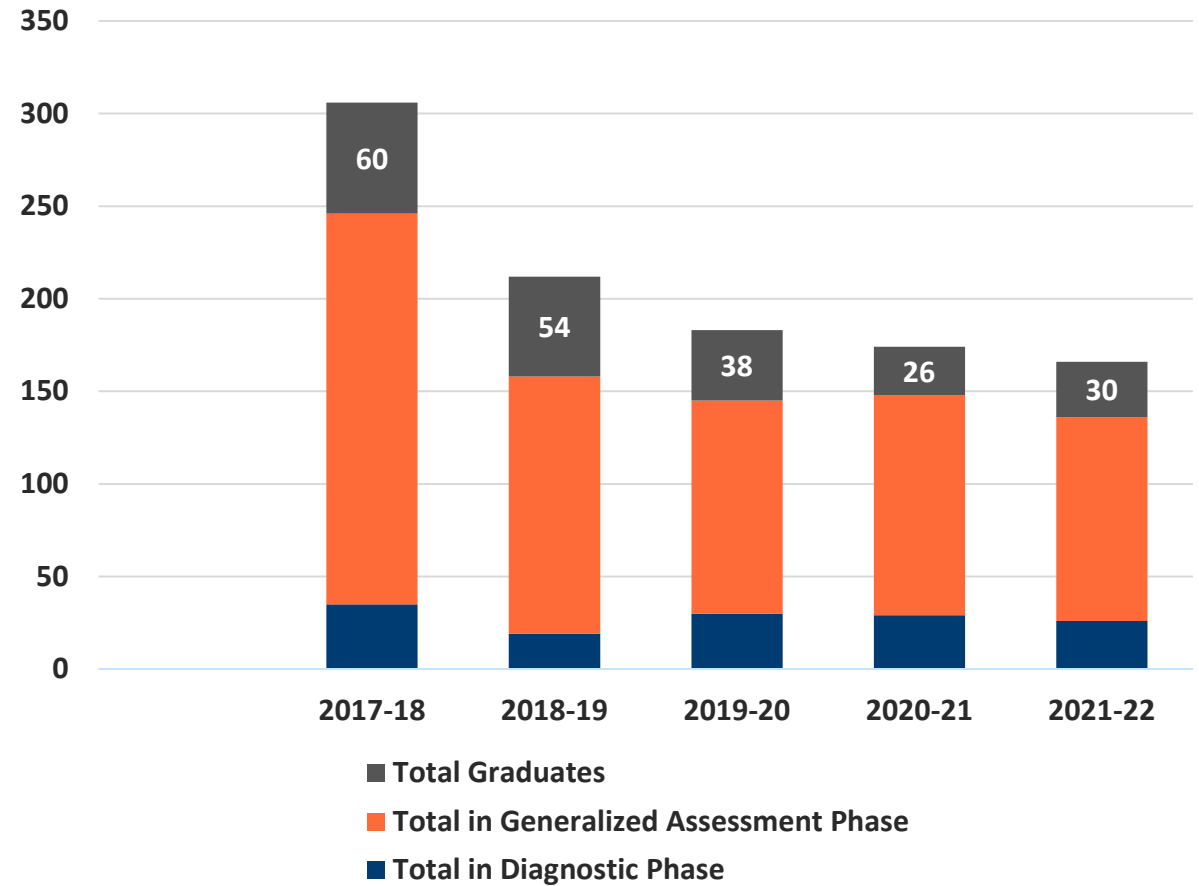


National External Diploma Program (NEDP)

Online, self-paced, competency-based HSE option

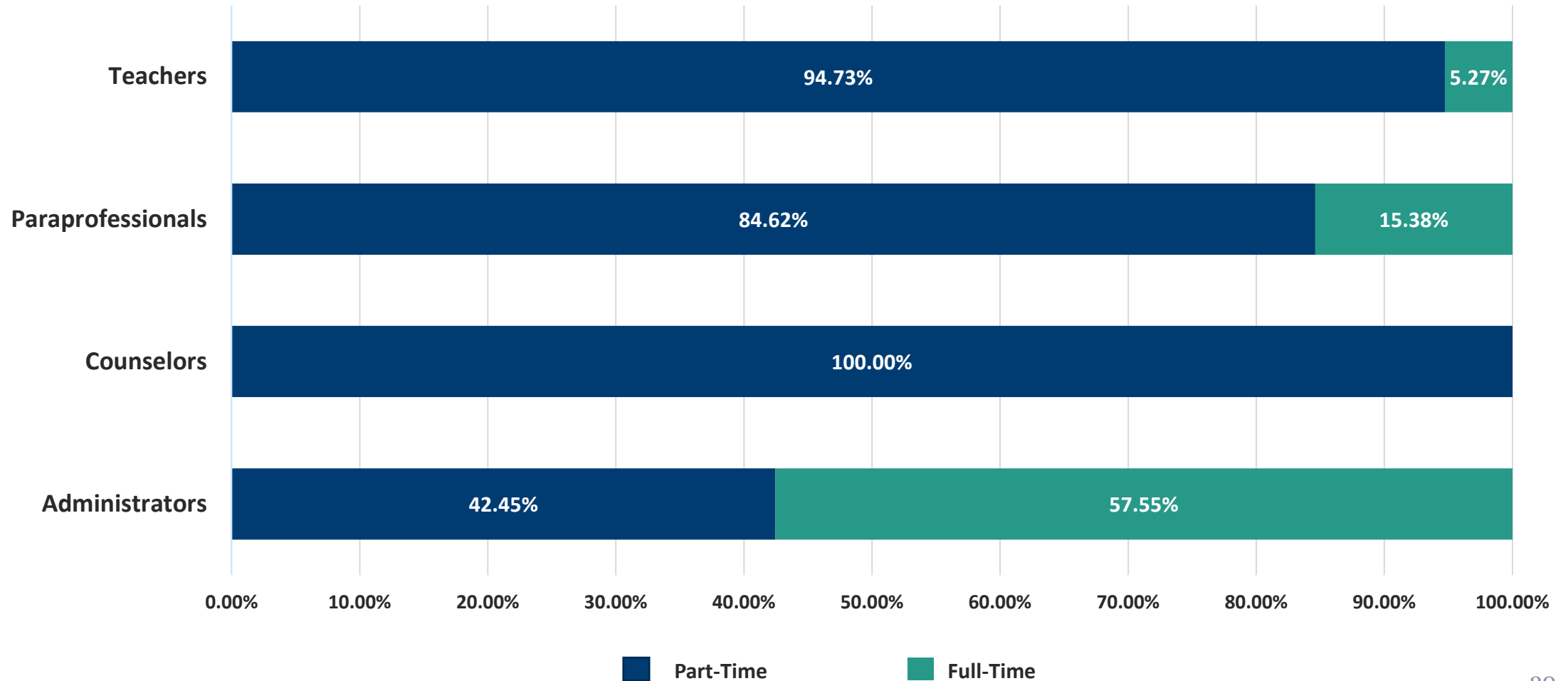
Graduates earn an Adult High School Diploma issued by a local school division

NEDP Enrollment and Graduates

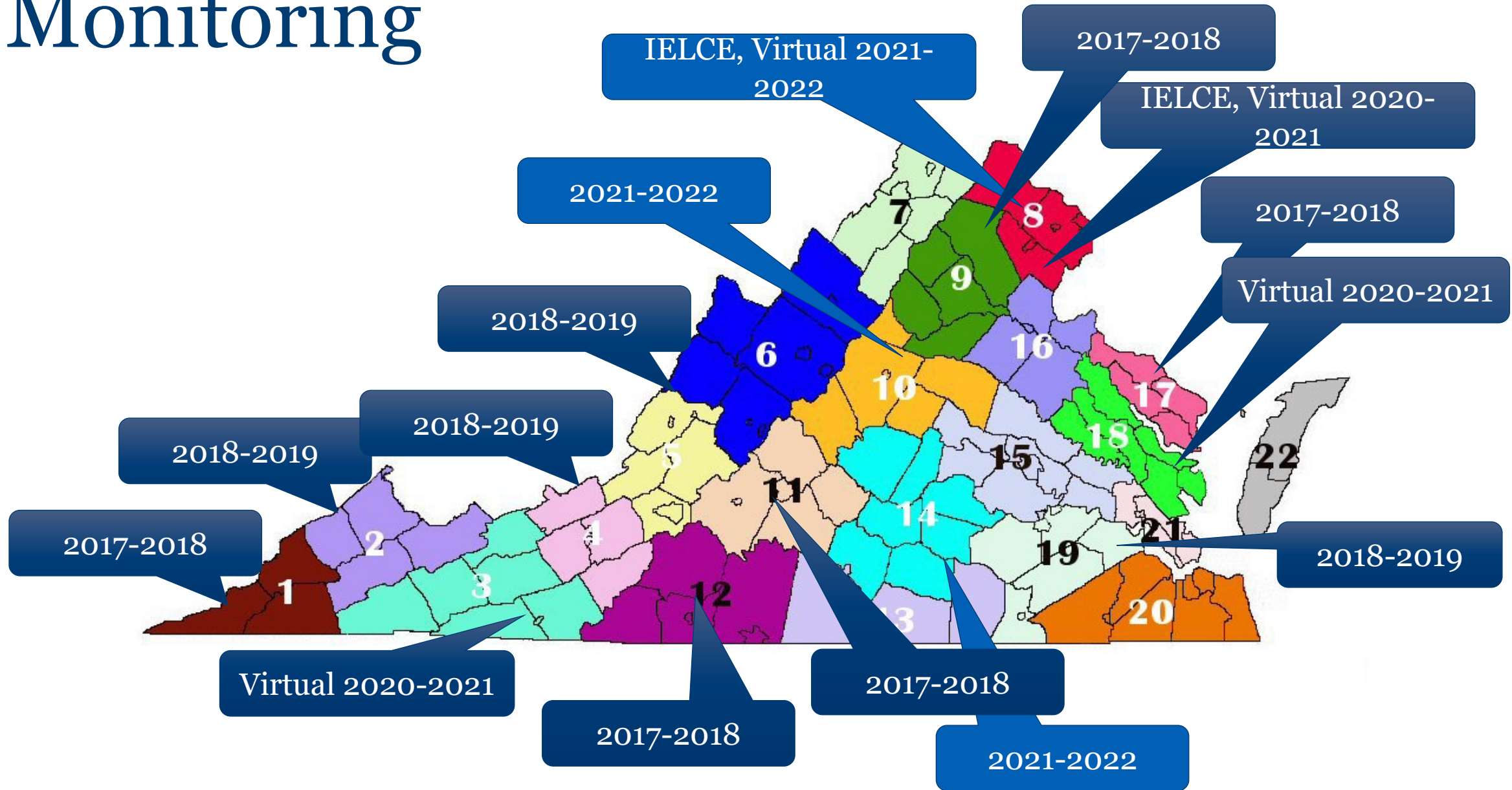

Career Coach Certification training was sponsored for a cohort of educators to:

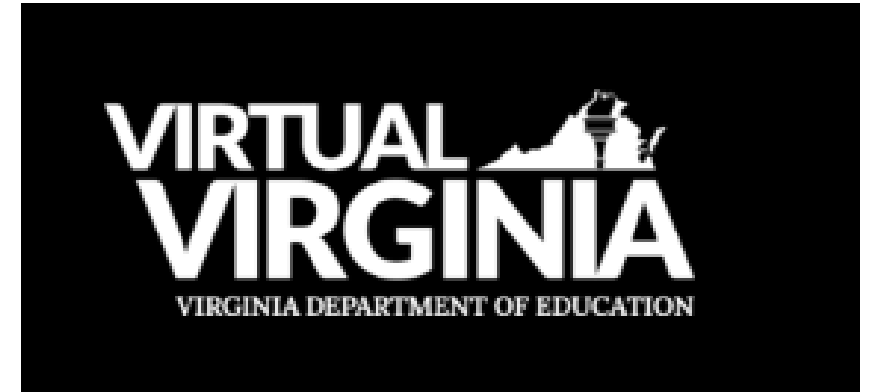
- Gain career coaching and LMI skills

- Facilitation support from Virtual Virginia and the VALRC

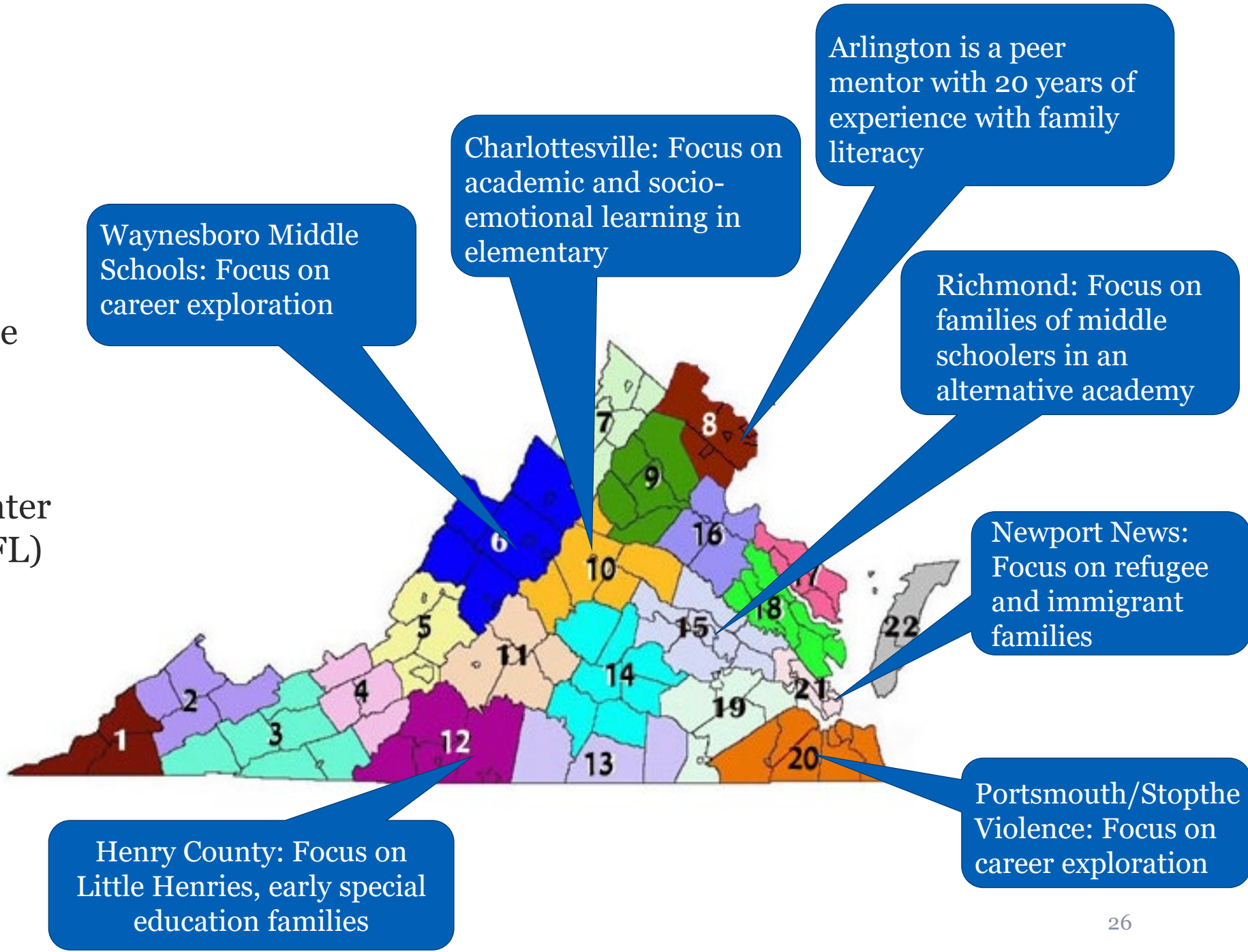




Family Literacy

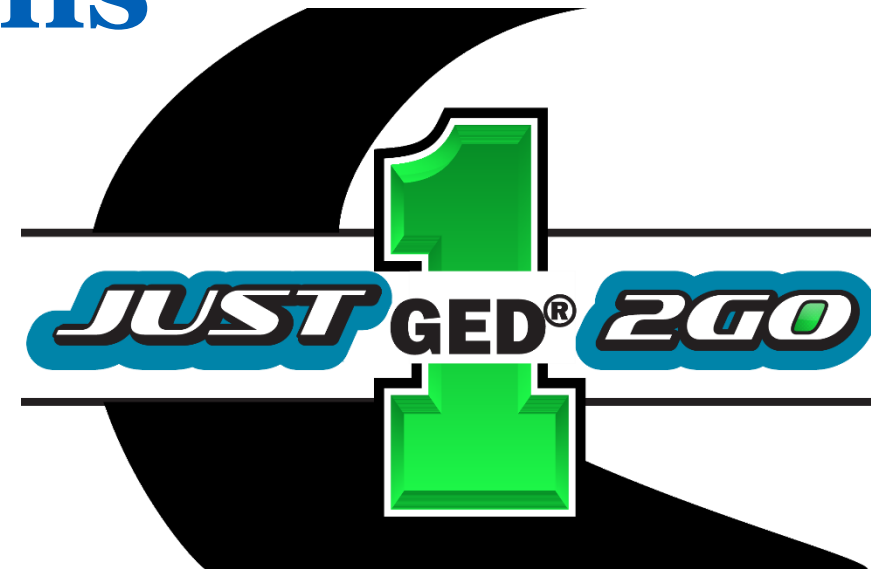
Offering place-based service in 2022-2023.

“Test for Free” Campaigns

- Ongoing “Test for Free in VA” campaigns for adult education students
 - Additional vouchers were purchased to support up to 712 testers (4 subtests each)
 - Programs are focusing on outreach to GED® testers with “Just 1 to Go”
 - 10% of our “Just 1 to Go” list has completed their credential
- Online proctored and in-person testing availability is returning to pre-pandemic levels



Innovation Challenge Awards 2022-23

\$810,000 awarded in September to fund expansion projects:

- **Serve the re-entry population** through a coalition of service providers in the Shenandoah Valley and in Scott county;
- **Prepare incarcerated individuals** for successful release by expanding service in correctional facilities in Henry, Patrick, and Richmond counties;
- **Expand service to underserved communities** through partnerships such as those with public libraries in Damascus, Petersburg, Pulaski, and Shawsville; and
- **Offer integrated education and training (IET) opportunities** for industry-recognized credentials on the Eastern Shore, in the Peninsula, Shenandoah Valley, and Piedmont regions and in the cities of Petersburg, Lynchburg, and Charlottesville.
