

- \$20M in Launch Grants

Department disburses funds to Awardee (IHE/eligible entity) 30%-30%-30%-10% during the term (NTE 12 months)

Department submits reports on funding as required by the General Assembly

#### **State Board of Education**

SBOE's appointed Standing Committee Reviews & Recommends Lab School Launch Applications

Board Approves Lab Schools and determines disbursement of Start-up Grants and Per-Pupil Operating Funding Grants to IHE/eligible entity

Department will disburse funds for SBOE accordingly upon Lab School approval

#### **IHE/Eligible Entity**

IHE/Eligible Entity will receive under a Planning, Start-up, or Per-Pupil Operating Funding Grant

IHE/Eligible Entity will disburse any funds to partners in a Lab School effort (e.g., school division), in accordance with Department's Grant Award Notification (GAN) and terms and conditions of award.


### Lab School Standing Committee



- 5. 2020- Board lowers cut scores of Reading SOL tests.

# Accreditation & Accountability Reform

Virginia's accreditation and accountability systems do not provide parents with an accurate picture of what is happening in schools.

## Accreditation & Accountability Reform

#### Action 1: Raise the floor and the ceiling

 Direct the Board of Education to raise Virginia's expectations for students from the lowest in the nation to the highest by the time our students take their SOL exams next spring.

#### Action 4: Hold Ourselves and Our Schools Accountable

- Direct the Board of Education to overhaul our broken school accreditation system, which currently masks the fact that too many students are being failed across the Commonwealth.
- Design a system to hold schools accountable for results by providing a clear picture of how every school is serving its students.

# OUR COMMITMENT TO VIRGINIA'S CHILDREN

#### Accreditation & Accountability Reform – Guiding Principles

Our Vision: We will develop a state of the art accreditation and accountability system to ensure all schools are preparing every student for success.

- 1. Our North Star is high expectations for every student. Proficiency definitions will be set by benchmarking against the demands of Virginia employers and higher education, as well as against states who have the most rigorous definitions of proficiency in the nation.
- 2. Transparency and access to actionable information will be a hallmark of our approach and our new system.
- 3. Student academic growth and proficiency are both vital measures, but the **system must prioritize getting every student to proficiency**.
- 4. The purpose of accountability is **to build trust, not to shame and blame**. We must be able to see clearly to provide necessary supports and work alongside schools in need of help.
- **5. Stakeholder input is critical**. Teachers, parents, students, and education leaders will inform the Board's process to build a best-in-class accreditation and accountability system.
