





Undergraduate enrollments increased from Fall 2022 to Fall 2023. Public four-year and two-year enrollments remain below pre-pandemic levels.




COVID-Pandemic

Overview of Virginia Higher Education

Strengths

- Diverse set of institutions.
- Strong outcomes in graduation rates and post-graduate earnings.
- Among top two states for higher education (Source: SmartAsset).

Challenges

- Enrollment declines at some institutions.
- National question of the value of a college degree and affordability.
- Variation in outcomes by institution.
- Growth in costs.

Institution Priorities and Funding Requests

- **Base Operational Support:** Inflation, operations and maintenance of new facilies, funding disparities, campus safety, IT infrastructure, and faculty recruitment and retention.
- Virginia Military Survivor and Dependents Education Program: Funding to offset growth in tuition waiver costs.
- **Career Readiness/Workforce:** Internships, career advising, and outreach to business community.
- Mental Health: Increased staff and program supports.
- **New Programs:** Healthcare, teacher preparation, medical education, AI, and computer science.
- **Student Support:** Supports to improve retention and completion.

Governor's Introduced Budget

SB 29 & SB 30: Summary of Proposed Amendments

SB 29: Proposes \$1.8 million GF the second year to fund the state match and maximize federal funds received due to Virginia State University's status as an 1890 Land Grant Institution.

SB 30: Proposes a net increase of \$67.2 million GF in FY 2025 and a net decrease of \$11.6 million GF in FY 2026, resulting in a **net increase of \$55.6 million GF** over the biennium.

Other Funding Related to Higher Education:

 Virginia Biotechnology, Life Sciences and Pharmaceutical Manufacturing Network: Proposes \$100.0 million GF the first year to support research initiatives at UVA, VT, and VCU. This includes the transfer of \$7.5 million in VCBA funds that were designated to support a similar project at UVA.

Other Education:

• No GF allocations. NGF adjustments for VA Museum of Natural History.

SB 30: Language Amendments -Systemwide

- Maintain affordable access operational support (\$75.0 million each year): Recommends repurposing funding authorized in Chapter 1, 2023 Special Session I.
 - Requires the Secretary of Education and SCHEV to establish a set of performance standards and targets.
 - Authorizes the Secretary of Education to determine funding allocations in the second year and specifies that amounts are contingent upon institutions limiting in-state undergraduate tuition and mandatory E&G fee increases to the lower of 2.5 percent or inflation and submitting a performance plan.
- **Campus Safety and Security:** Funds are provided to institutions with the requirement to partner with the Virginia Fusion Center (VA Police and VA Department of Emergency Management).
- **Capital requirements:** Requires Level III institutions to provide 25 percent NGF to support education and general (E&G) projects that are new construction, major renovation, or an acquisition.

SB 30: Language Amendments - Aid

• Tuition Assistance Grant:

- Proposes to increase online amount from 50 percent of the campus-based award to 75 percent (an increase from \$2,250 to \$3,750).
- Requests SCHEV to reappropriate up to \$2.0 million in balances to study and implement an online system to facilitate applications for awards.

• FAFSA Simplification - Alignment of State Aid Language:

- Recommends language to align state aid with upcoming changes to the Free Application for Federal Student Aid (FAFSA).
- Provides a hold harmless for current students to continue state aid under current criteria.

SB 30: Language Amendments -Other

- UVA –Wise: Continue indirect cost recovery flexibility for the biennium.
- **Radford University:** Transfer Radford Carillion appropriation to Radford operating (E&G).
- Southeastern University Research Association (Jefferson Labs): Adjust language to allow use of existing funds for new high performance data facility project.
