Investing in Public Health Readiness

American Rescue Plan Act (ARPA) Initiatives



Facilities Broadband (\$8M) – VDH is modernizing and upgrading the internet infrastructure of Local Health District (LHD) offices and client service areas throughout the Commonwealth is fundamental to protecting the health and promoting the well-being of all people in Virginia.



Electronic Health Records –EHR (\$30M) – VDH will deploy an EHR system in a format that can be shared across Virginia’s healthcare ecosystem. A state-of-the-art EHR system will improve public health prevention activities, facilitate timelier diagnoses, and enhance public health reporting.



Local Health District Maintenance (\$30M) – VDH is implementing critical facility maintenance and local health district (LHD) upgrades to ensure all residents served by the Virginia’s public health systems, have equitable and safe access to the services and resources they need.

American Rescue Plan Act (ARPA) Initiatives



Administrative Systems (\$50M) - VDH will transform and modernize IT service management, business and financial management systems to bring the department into the 21st Century and enhance the Commonwealth's state of readiness to respond to public health emergencies.



Records Management Systems (\$30M) – VDH will to convert from a legacy paper-centric records management process to a streamlined and modernized digitized and automated system. This transformation will enable greater efficiencies to more effectively serve Virginians.
