Protecting the Public Health

- The mission of the Virginia Department of Health (VDH) is to protect the health and promote the well-being of all people in Virginia.
- Over the last year VDH has:
 - Responded to multiple drinking water emergencies across the Commonwealth (Richmond, Lake Anna, Orange County, South Hill fire)
 - Responded to Hurricane Helene
 - Ensure restaurants are safe to reopen after hurricanes, floods, and water events
 - Increased efforts to respond to the opioid and fentanyl crisis in Virginia
 - Investigated and responded to incidents in hospitals and nursing homes
 - Conducted screening of incoming passengers at Dulles when new diseases threatened
 - Worked to improve maternal and child health outcomes



Protecting the Public Health





JLARC Report Response

- In November 2024 JLARC released a report on the operations and management of the Virginia Department of Health. That report discussed many of the factors which have impacted VDH, including:
 - A large wave of COVID funding and the strain of COVID response on the agency
 - Historical under investment in administrative staff
 - Key staff turnover

VDH has already taken significant action:

- The Chief Operating Officer has led Monthly Operating Reviews of all programs over the last 15 months.
- Hired a Deputy Commissioner for Community Health Services, and a Deputy Commissioner for Population Health and Preparedness.



JLARC Report Response

- Hired a Chief Financial Officer, making it clear that financial accountability is of upmost importance across our organization. Now working with DOA (as recommended) on important financial hires.
- Created an Office of Grants Administration ensuring that accountability and compliance controls are front and center as we administer the over \$2 Billion of open federal grants. Director selected and will be onboarded in February 2025.
- Created the Controller position to oversee financial compliance and accounting processes. Candidate selected and will be onboarded in February 2025.



JLARC Report Response

- Hired Regional Health Directors to ensure that communication and accountability is improved across the 35 health districts. For the first time in many years, VDH has filled all local health director positions.
- Hired a new Director for the Office of EMS who will start on January 25th
- Taking steps to assure our health workforce incentive programs are accessible and responsive. In recent months, program added 6 staff to address the current Nurse Preceptor Program applications, focus on process improvement, and full implementation of the new database for all incentive programs in 2025.






Virginia Department of Health Funding Streams, Budget & Staffing Levels



Virginia Department of Health Appropriation by Fund 2016 - 2026



 The increase in federal funds in FY17 is largely due to AIDS/HIV grants and is not new funding, but a technical appropriation increase, as these funds increased in the last biennium (FY19 increase are also Ryan White related and just a technical). The FY21 increase is also about 50% Ryan White and the rest is largely due to central appropriation. FY24 is the DWRSF from the Infrastructure Bill.

Maternal and Child Health



Budget Amendments

Provide funding for a perinatal health hub pilot program
Provides funding to support a perinatal health hub pilot program in Virginia to reduce maternal and infant mortality.
FY26 - \$ 2,500,000 GF

• Add support for community health workers and doulas at local health districts

Provides additional support for community health workers and doulas at local health districts that serve localities with the highest rates of maternal mortality.

FY26 - \$ 1,000,000 GF





FY 2026 Budget Amendments

Regulating healthcare facilities



Budget Amendments

 Provide support for the Home Care Organization Licensure Program Provides support for the Home Care Organization Licensure Program's biennial inspection workload.

FY26 - \$ 853,098 GF

• Provide support for intermediate disciplinary actions for medical care facilities

Provides support for the administration of intermediate disciplinary actions for medical care facilities. This funding is tied to forthcoming legislation.

FY26 - \$ 319,883 GF





FY 2026 Budget Amendments

Office of Emergency Medical Services (OEMS)



Office of Emergency Medical Services (OEMS)

- Remove budget language that prohibits changes to emergency medical services council regional boundaries
 - Eliminates restrictive language that prevents changes to current emergency medical services regional council boundaries.

Improving Compliance



Budget Amendments

Provide support to maintain compliance with drinking water regulations
 Provides additional support to the Office of Drinking Water to maintain
 compliance with state and federal drinking water requirements.

FY26 - \$ 1,803,598 GF

• Provide support for information technology security audits and mandatory investigations

Provides support to the Office of Internal Audit for additional financial and information technology auditors to address an increase in workload. FY26 - \$ 847,529 GF

Title	Summary
Increase vital records fee for expedited records	Increases the amount charged for expedited records from \$48.00 to \$53.00 to cover for increased services costs.
Amend language for the State Pharmaceutical Assistance Program to expand access to purchase HIV prevention medication	Amends language for the State Pharmaceutical Assistance Program to expand access to purchase pre-exposure prophylaxis (PrEP) and non- occupational post exposure prophylaxis (n-PEP) HIV prevention medication, co-pays, and other out-of-pocket costs.
Restrict taxpayer funding for abortion services	Prevents expenditures from general or nongeneral fund sources to be used for providing abortion services, except as otherwise required by federal law.
Update language to reflect current funding levels for the Virginia Center for Health Innovation	Updates language to reflect current funding levels for the Virginia Center for Health Innovation.
